

Sydney FC Holiday Clinic Terms and Conditions

1.1 Product

Sydney FC reserves the right to change any of the clinic package details including locations, dates and times at any point in time.

Sydney FC reserves the right to not accept any registration for clinics in its absolute discretion.

1.2 Venue & Equipment

Registrants are expected to adhere to all guidance by Sydney FC coaches, staff , other representatives in relation to treatment of clinic venue(s) and venue property and equipment. Sydney Football Club shall not be liable for any matters related to damage to clinic venue, property and equipment and will pass on any incurred costs as a result of damage to the participant at fault.

1.3 Discount Eligibility

Sydney FC provides discounts to its clinics based on two factors:

- a) Any registrant who is a current financial member of Sydney FC for the current season is entitled to a 10% discount.
- b) Any parent who is registering more than one sibling, is eligible for a 10% discount for two siblings, and 15% for three or more siblings. Please note this does not apply for friends, the sibling discount is for family members only.

Please note these discounts cannot be used in conjunction with each other or other offers.

1.4 Cancellation, Refunds and Replacements

Once your registration is sent to the Club you cannot cancel your booking, without limiting clause above, refunds and exchanges are allowed only as expressed in this Agreement.

In the circumstance that the clinic is cancelled due to wet weather, fees will be credited to the next school holiday clinic only. Please note that credits not used at the next school holiday clinic are forfeited and cannot be refunded.

3 day wet weather cancellation = \$200 credit

2 day wet weather cancellation = \$120 credit

1 day wet weather cancellation = \$40 credit

Credits are not pro-rated if a clinic is cancelled during the day. If there is more than one and a half hours play, no credits are applied. If there is less than one and a half hours play, a full day credit will be issued.

Sydney FC also reserves the right to cancel any registrations at any time if, in Club's opinion, a participant engages in disruptive behaviour which is deemed

inappropriate (physically or emotionally), or likely to be prejudicial, to the interests of fellow participants, coaches, staff members or other related parties.

1.5 Privacy

Sydney FC respects the privacy of the individuals on whom it collects, uses and discloses personal information. The personal information that the Club collects is used for the purpose of processing your registration and providing you with Football related information and offers from the Club.

A copy of Sydney FC's Privacy Policy is available to any member upon written request.

1.6 Use of Images

Sydney FC advises that photographic and film images of participants at each clinic may be used for the purpose of promotion and marketing of the game.

If you do not wish the participant to be used, you must supply in writing or at time of registration your non approval.

1.7 Liability of Injury

The participant and their parent understands that by submitting their registration that the Event, and participating in the Event, carries with it inherent dangers and/or risks of physical injury, including serious injury such as permanent disability, paralysis and even death. The participant understands that they are voluntarily participating in the Event with knowledge of the potential dangers and/or risks involved, and agree to assume any and all dangers and/or risks of bodily injury or death, whether those dangers and/or risks are known or unknown.

In consideration of being allowed to participate in the Event the Participant individually agrees to forever release and hold harmless the Football Federation Australia Limited, Sydney Football Club Pty Limited , its directors and employees in the event of injury to any Participant. We also acknowledge that the Football Federation Australia Limited and Sydney Football Club Pty Ltd does not have in place any personal accident insurance policy that would provide us with any compensation or benefits in the event of any Participant being injured.

1.8 Liability of personal items

Whilst Sydney FC use best endeavours to select appropriate secure locations for the use of our holiday clinics, registrants and their parents acknowledge that Sydney FC takes no responsibility for personal items that are lost. Where possible, If any items are found by Sydney FC staff, the club holds a lost property service to ensure goods are returned to rightful owners.

1.9 Summer Clinic 2016 Early Bird Promotion
